

2025 PASTA CHAMPIONSHIP ASIA TERMS AND CONDITIONS

The Pasta Championship Asia (hereinafter referred to as "Contest") consists of a competition opened to chefs de cuisine, sous chefs and chef de partie, operating in following countries: Singapore, Malaysia, Japan, China, India, Philippines, Vietnam, South Korea, with a minimum age of 18 at the time of their registration, who meet the requirements listed below.

The submission phase period will start from January 31st, 2025.

All participants (hereinafter also referred to as "Participant" or "Participants") are invited to carefully read these terms and conditions (hereinafter also referred to as "Terms and Conditions"). By participating in this Contest, Participants declare that they have read and fully understand and accept the Terms and Conditions.

A. SCOPE OF THE CONTEST

The Contest is opened to **chefs de cuisine**, **sous chefs** and **chef de partie**, working in restaurants, hotels, food service operators with a pasta meal offering, operating in following countries territories: Singapore, Malaysia, Hong Kong, Japan, China, India, Philippines, Vietnam, South Korea, with a minimum age of 18 at the time of their registration

B. ORGANIZER AND SPONSOR

The Contest is organized by the Barilla distributors / business partners reported below (hereinafter referred to as "**Organizer**") and sponsored by Barilla Singapore Pte Ltd (hereinafter also referred to as "**Sponsor**").

C. CONTEST DURATION

The total duration of the Contest will be approximately (10) ten months starting from January 31st 2025, the date on which the Contest will be published on the following website link (which may be amended from time to time): https://barillaforprofessionals.com/global/pastachampionshipasia

The Contest will be made up of (4) four phases:

- 1) The first (1st) phase (hereinafter also referred to as "*The 1st phase*" or "*The Submission phase*") will start from January 31st, 2025 and will end -in the below dates for the respective territories:
 - April 15th, 2025 for Singapore, Malaysia, India, Philippines, Hong Kong and China
 - May 31st, 2025 for Japan, South Korea and Vietnam
- 2) The second phase will start from April 15th, 2025 and will end on -June 30th, 2025 (hereinafter also referred to as "*The Second phase*" or "*The National screening phase*").
- 3) The third phase will start from May 1st, 2025 and will end on September 15th, 2025 (hereinafter also referred to as "*The Third phase*" or "*The National winner phase*").
- 4) The fourth phase will take place in October, 2025 (hereinafter also referred to as "The Fourth phase" or "The Asia winner").

Dates and times are subject to change at the Organizer's discretion.

D. PARTICIPATION REQUIREMENTS

Participation in this Contest is exclusively open to chefs who have the following requirements:

- age above 18 years; and
- experience: they must currently work in a restaurant or hotel or other food service operators which have pasta in their menu, as a "chef de cuisine" or "chef de partie" or "sous chef", and with at least 3 years of working experience as a chef in the food & beverage industry and able to communicate clearly in English (min. B1 level).

Sponsor's and Organizer's parent, subsidiary and affiliate entities and their respective officers, directors, agents, and employees, as well as their immediate family (spouse, parents, siblings and children), are not eligible to enter into the Contest or win.

E. APPLICATIONS SUBMISSIONS

To participate, the chefs who have met the requirements listed above, must register by submitting their application ("Application") on https://barillaforprofessionals.com/global/pastachampionshipasia.

By submitting their Application, the participants accept these Terms and Conditions and any other rules, terms and conditions applicable to the Contest (including but not limited to safety requirements for the Contest) that may be specified or made known by the Organizer from time to time.

The order in which Applications will be submitted does not affect their acceptance and shall not give rise to any preferential treatment.

Participants shall complete their registrations by their respective deadlines in the territory of participation. -

Applications shall be accepted only in English.

- The Application form must be filled in English with the following information:
 - name, email address, phone number; and

- current job position and place of work.
- Participants must also attach:
 - A participant picture at high resolution with chef jacket;
 - updated CV or short biography;
 - the recipe for the dish (4 portions), which uses Barilla Spaghetti N.5 or Barilla Penne Rigate as "hero product" of the recipe; and
 - pictures of the dish

Although it is not mandatory, we recommend Participants provide also a short video (max 2') where the chef will present himself, the restaurant where he works, and his culinary philosophy (optional).

Important notes:

- The pasta needs to be the focal element of the dish
- In line with the mediterranean nutritional model guidelines, each portion of pasta dish should utilize 85 grams of dry pasta
- The recipe will need to include the step-by-step process
- The Participant shall ensure that if the Participant submits any recipe or material from the Participant's current place of work, the Participant has obtained the requisite consent or approval from the Participant's employer or authorised representative from their place of work before submission.
- The recipe of the dish attached by the Participant must be an original creation and not copied or reproduced from the Participant's employer or place of work.

F. CONTENT RESTRICTIONS

By participating in the Contest, Participants fully understand and unconditionally agree to the following content restrictions rules:

- the Application must not contain material that violates or infringes any third party's rights, including but not limited to privacy, publicity or Intellectual Property Rights, or that constitutes copyright infringement;
- the Application must not disparage the Sponsor, its products or services, or the Organizer or any other person or party whether or not affiliated with the Contest;
- the Application must not contain brand names or trademarks other than those owned by Sponsor, or those in which the Participant has a limited license to use to incorporate in his/her Application in this Contest;
- the Application must not contain material that is inappropriate, indecent, obscene, hateful, tortious, defamatory, slanderous or libelous;
- the Application must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age;
- the Application must not contain minors' images or personal data; and
- the Application must not contain material disclosing any sensitive personal data (i.e. health data, sexual, political orientation, data revealing racial or ethnic origin, religious or philosophical beliefs, or trade union membership, as well as genetic and biometric data, data concerning a person's health or sex life or sexual orientation)

G. CONTEST PROCEDURE

Phase 1: "The Submission phase"

Every Participant who submits her/his Application documentation by -stipulated deadline via the form on https://barillaforprofessionals.com/global/pastachampionshipasia will receive an email confirming the receipt of the Application. The Organizer and/or the Sponsor reserve the right to request additional information.

Phase 2: The National screening phase

All Applications received during Phase 1 shall be assessed by the Organizer and/or the Sponsor in their sole discretion.

The evaluation criteria will be the following:

- The aesthetics/visual appeal of the dish
- Harmonious mix of elements
- Skills in terms of preparation techniques
- Respect for Pasta cooking (texture)

The Organizer and/or the Sponsor shall define a shortlist of 6 chefs / Participants for each country.

In the event of the number of valid Applications for one or more areas being less than 20, the shortlist can be made up of a smaller number of Participants.

The Participants who have been shortlisted will be notified by email.

All Participants who are not selected will receive an individual email by June 30th 2025. The decision of the Organizer and/or the Sponsor is final and no appeals from non-selected Participants will be entertained.

Phase 3: The National winner phase

The 6 Participants shortlisted for each territory, will take part in the National winner phase, which will be held in following cities and dates:

The dates may be subject to variations due to organizational reasons and will be communicated in advance to Participants.

At the end of the National winner phase, a sole winner for each country will be selected by the Organizer and the Sponsor in their sole discretion. The winner for each country will participate in the next phase (Grand Finale).

The judging panel will be composed of:

- Chef Andrea Tranchero Executive Chef Barilla APAC
- Culinary School Director or Chef Association representative
- Journalist of Food Service channel

or any other equivalent experts in food service.

For the avoidance of doubt, the Organizer and/or the Sponsor is entitled in their sole discretion to replace any member of the judging panel without notice to the Participant.

Travel costs: for trips longer than 100km, the Sponsor will provide the cost of travel and accommodation for 1 night.

The detailed regulations for the phase 3 are reported in the **ATTACHMENT A**.

The winners of the phase 3 will participate to the final competition which is subject to their ability to travel to the location of the Grand Finale and any other legal or regulatory requirement (including but not limited to visas) for them to attend the Grand Finale. For the avoidance of doubt, in the event that the winner(s) are unable to travel to the location of the Grand Finale for the final competition, the Organizer and the Sponsor reserve the right to replace the relevant winner(s) with another Participant at their sole discretion.

Phase 4: Final competition ("Grand Finale")

The final competition is scheduled to take place on October 24, 2025. The Grand Finale will be held in one of the eight territories mentioned in Phase 3. However, the location and date of the final competition may be subject to change due to organizational reasons. Any changes will be communicated to Participants in advance.

H. JURY MEMBERS, SCORE ASSIGNMENT AND EVALUATION CRITERIA

At the Grand Finale, each finalist of the "2025 Pasta Championship Asia" shall cook their pasta dishes, that shall be assessed by a panel of jury members made up of:

- Chef Andrea Tranchero Executive Chef Barilla APAC
- Executive Chef
- Culinary School Director or Chef Association representative
- Journalist of Food Service channel
- Food Designer

or any other equivalent experts in food service.

For the avoidance of doubt, the Organizer and/or the Sponsor is entitled in their sole discretion to replace any member of the panel without notice to the Participant.

The detailed regulations, score assignment and evaluation criteria for the phase 4 are reported in the **ATTACHMENT B.**

I. WINNER NOTIFICATION

The winners of the Grand Finale will be notified at the end of the Contest.

J. PRIZES AND CLAIM

This is a skill-based Contest and chance does not play any part in the determination of the Contest winners.

The Organizer will contact the winners to provide the prizes. The prize may not be claimed by a third party on behalf of the winner. All prizes are personal to the winner, and are non-transferable and non-exchangeable for cash or any other item.

The Organizer will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not claimed their prize within 30 days of the announcement date, the Sponsor and the Organizer reserve the right to offer the prize to the next eligible Participant selected from the correct entries that were received before - the stipulated deadline.

The Organizer and Sponsor do not accept any responsibility if the winner is not able to take up the prize. All prizes are given out on an "as is" basis, and to the maximum extent permissible under applicable laws, the Organizer and Sponsor makes no representation or warranty as to the quality, suitability, availability, or fitness for purpose of the prizes. The use of the prizes may be subject to additional terms and conditions that may be made known to the winners when receiving the prizes.

All prizes given out to Contest winners may be subject to tax deductions, withholding or contribution, and subject always to applicable law, the Contest winners shall be solely responsible for the declaration of the prize to the relevant taxation authorities (where applicable) and the payment, deduction, withholding, and/or contribution (as the case may be) of any such tax on the prize awarded. If the relevant tax laws that are applicable to a Contest winner require the Organizer and/or Sponsor to pay, deduct, withhold, and/or contribute any part of the prize for tax purposes, such Contest winner shall as soon as reasonably practicable provide to the Organizer and/or Sponsor (as the case may be) all documents required for such payment, deduction, withholding, and/or contribution (as the case may be).

K. PRIVACY POLCY "2025 PASTA CHAMPIONSHIP ASIA

Barilla Singapore Pte Ltd is committed to protecting the privacy of Participants in the various initiatives it organizes (including the Contest). This section K has been prepared to allow the Participant to understand how the Participant's personal data (the "Personal Data") will be processed for the purposes of the Contest.

In general, any information or Personal Data that the Participant provides to the Sponsor as part of the Initiative will be processed according to the internationally recognized principles of lawfulness, fairness, transparency, purpose and storage limitation, data minimization, accuracy, integrity and confidentiality.

1. Data Controller and Data Protection Officer

The Sponsor is the data controller ("Data Controller") in relation to the Personal Data processed for the Contest. You can contact the Sponsor by writing to the e-mail address: privacy-sgp@barilla.com.

2. Personal data subject to processing

As part of the Contest, the Sponsor will collect and process the Participant's Personal Data, which may include:

- Identifiers (e.g., first name, last name, etc.).
- Contact information (e.g., email address and phone number).
- Image and voice data relating to the photos and recordings of the Participants that will be taken during the Contest or shared by the Participant during registration ("Image").
- Other information (e.g., country of origin).

3. Purpose of the processing

The Sponsor will collect, use and/or process the Participant's Personal Data for the following purposes:

- to allow the Participant to participate in the Contest, manage the activities related to the Contest and provide the Participant with any further assistance the Participant may need, as well as to follow up on the Participant's requests for re-contact ("Participation in the Contest and Recontact");
- comply with legal obligations that require the Sponsor to collect and/or further process certain types of Personal Data ("Compliance");
- protect the rights, property or safety of the Sponsor, its affiliates, business partners, employees or customers, for example, in legal proceedings, internal investigations and investigations by competent authorities, as well as prevent or detect any abuse in participation in the Contest or any fraudulent activity, for example by recording the Personal Data of those who have tried to commit fraud against the Sponsor in the context of the Contest, to protect the Sponsor from further attempts ("Abuses/Frauds"); and
- for promotional and informative purposes, which includes publication of images and videos in which the Participant's Image may be inserted, without any obligation to do so for the Sponsor, possibly in segmented or partial form and together with other images or contents, including those concerning the Sponsor's brand and/or that of its affiliated companies, on the internet (e.g. company website, social networks on pages linked to the Sponsor and/or its associated companies, electronic newsletter of the Sponsor), in internal presentations and on the corporate intranet of the Sponsor and/or its associated companies, excluding the commercial purposes of direct sale of products and services, as well as the analysis of the same using artificial intelligence tools. ("Publication and analysis of the Images").

4. Legal bases and mandatory or optional nature of processing

The legal bases used by the Sponsor to process the Participant's Personal Data, according to the purposes indicated in the previous paragraph, are as follows:

Participation in the Initiative and Recontact: the processing for these purposes is necessary in order
to allow the Participant to participate in the Contest or to respond to the Participant's requests for
recontact, therefore, to follow up on the Participant's request and as necessary for the execution of
the contract or pre-contractual measures in place with the Participant. The provision of the

- Participant's Personal Data to the Sponsor for these purposes is not mandatory, but otherwise it will not be possible to participate in the Contest and respond to the Participant's requests for recontact.
- Compliance: the processing for this purpose is necessary for the Sponsor to be able to comply with any legal obligations. When the Participant provides Personal Data to the Sponsor, they will be processed according to the applicable legislation, which may involve their storage and communication to the relevant authorities for accounting, tax or other obligations.
- Abuse/Fraud: the information collected for these purposes will be used exclusively to prevent and/or detect any fraudulent activities or abuses in the context of participation in the Contest, as well as to protect the interests of the Sponsor in and out of court as legitimate interests of the Sponsor.
- Publication and analysis of Images: the processing for this purpose is based on the Participant's consent, free and optional, which the Participant can revoke at any time by following the instructions in the "Participant's rights" paragraph below.

5. Disclosure of Personal Data

The Participant's Personal Data may be shared with the following parties (the "Recipients"):

- subjects who typically act as data processors such as, for example, persons, companies or professional firms that provide assistance and advice to the Sponsor in accounting, administrative, legal, tax, financial and debt collection matters relating to the management of the Contest, as well as persons delegated to carry out certain activities;
- subjects with whom it is necessary to interact for the management of the Sponsor's activities (e.g. hosting providers or providers of platforms for sending emails);
- subjects delegated to carry out technical maintenance activities (including the maintenance of network equipment and electronic communication networks);
- subjects or entities who are involved in the organization, marketing or administration of the Contest (including but not limited to the Organizers);
- persons authorised by the Sponsor to process Personal Data necessary to carry out activities strictly related to its business, including in relation to the Contest, who have committed themselves to confidentiality or have an appropriate legal obligation of confidentiality (e.g. the Sponsor's employees);
- the Sponsor's group companies for internal administrative and accounting purposes; and
- subjects, bodies or authorities to whom it is mandatory to communicate the Participant's Personal Data for Compliance, Abuse or Fraud purposes, or by orders of the authorities.

6. Transfers of personal data

The Sponsor will ensure that any transfer of Personal Data overseas will comply with the applicable requirements.

7. Retention of Personal Data

Personal Data processed for the purposes of participation in the Contest and the Participant's Personal Data will be kept by the Sponsor for the time strictly necessary to pursue the aforementioned purpose(s). In any case, since such Personal Data are processed to allow the Participant to participate in the Contest and respond to the Participant's requests, the Sponsor may retain them for a longer period, in particular as may be necessary in order to protect the Sponsor's interests from possible liability related to the Contest.

Personal Data processed for Compliance purposes will be stored by the Sponsor for the period provided for by specific legal obligations or applicable legislation.

Personal Data processed in order to prevent Abuse/Fraud will be stored by the Sponsor for the time strictly necessary for the aforementioned purpose and therefore until the Sponsor is required to retain them to protect itself in court or to communicate such data to the competent authorities.

With regard to the Personal Data processed for the purpose of Publication and analysis of the Images, the same will be processed until the Participant revokes the consent expressed by the Participant; it should also be noted that the Image will be stored for a period of time equal to 12 months from the conclusion of

the Contest, without prejudice to any revocation of consent or opposition to processing if prior to the expiry of this term.

At the end of these retention periods, in accordance with the principle of storage limitation, the Sponsor will delete or anonymise Personal Data so as to ensure that it cannot be reconstructed or read.

8. Rights of the data subject (Participant's rights)

The Participant has the right to ask the Sponsor, at any time and in accordance with applicable legislation:

- Access to the Participant's Personal Data (and/or a copy of such Personal Data), as well as further information about the processing taking place on them;
- The rectification or updating of the Participant's Personal Data processed by the Sponsor, where they are incomplete or outdated:
- The deletion of the Participant's Personal Data from the Sponsor's databases, where the Participant considers the processing unnecessary or unlawful;
- The restriction of the Sponsor's processing of the Participant's Personal Data, where the Participant believes that the Participant's Personal Data is incorrect, necessary or unlawfully processed, or where the Participant has objected to its processing;
- To exercise the Participant's right to data portability, i.e. to obtain a copy of the Personal Data that the Participant has provided to the Sponsor in a structured, commonly used and machine-readable format, or to request its transmission to another data controller;
- To object to the processing of the Participant's Personal Data, using a legal basis relating to the Participant's particular situation, which the Participant believes should prevent the Sponsor from processing the Participant's Personal Data.
- withdraw consent to the processing of the Participant's Personal Data for any of the purposes for which it was provided.

The Participant can exercise the above rights by submitting a request in writing to the Sponsor at the following address: privacy-sgp@barilla.com.

In any case, the Participant always has the right to lodge a complaint with the competent regulatory authority if the Participant believes that the processing of the Participant's Personal Data is contrary to the applicable legislation in force.

L. INTELLECTUAL PROPERTY

For the purpose of these Terms and Conditions, 'Intellectual Property Rights' means all copyright, patents, trademarks, designs, rights in trade secrets, moral rights, know-how and all other intellectual property rights, subsisting now or in the future in any part of the world, whether registered or unregistered, including all applications or rights to apply for such rights, and all other rights in ideas, inventions, discoveries, goodwill and confidential information.

By participating in the Contest, the Participant hereby acknowledges and agrees to grant the Released Parties (defined below) a non-exclusive, perpetual, irrevocable, fully paid-up, royalty free, transferrable, sub-licensable and world-wide license to access, use, publish, reproduce, integrate, modify, transfer, and distribute any Intellectual Property Rights in all materials, content, creations, logos, statements and products (including any part or derivative of the foregoing) that has been provided or created by the Participant in connection with or arising out from the Contest, which includes but is not limited to the Participant's Application and their recipes.

Unless otherwise expressly agreed in writing, the Organizer and the Sponsor shall retain all rights, titles and interests in and to their own Intellectual Property Rights that were owned by them (or their licensors) prior to the Contest and no such rights, titles or interests shall be granted to the Participant.

Unless otherwise expressly provided in these Terms and Conditions, any Intellectual Property Rights that are created or developed in connection with or arising out from the Contest shall be owned by and vested in the Sponsor, subject to any agreement between the Sponsor and the Organizer.

M. LIMITATIONS OF LIABILITY

By participating in the Contest, the Participant agrees, to the maximum extent permissible under applicable laws, to release, indemnify and hold harmless the Sponsor and the Organizer, including their respective parent companies, subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim, demand, proceeding, loss, damage, remedy, cost or cause of action arising out of or in connection with the Participant's participation in the Contest.

To the maximum extent permissible under applicable laws, the Participant hereby agrees that the Released Parties shall not be held responsible for:

- 1) any incorrect or inaccurate information, whether caused by the Participant, printing, typographical or other errors or by any of the equipment or programming associated with or utilized in the Contest;
- 2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software, including misdirected or undeliverable Applications or for any technical problems, malfunctions of computer systems, servers, providers, hardware/software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmission or any combination thereof;
- 3) unauthorized human intervention in any part of the Application process or the Contest and any unauthorized third party use of any Application;
- 4) printing, typographical, technical, computer, network or human or other error which may occur in the administration of the Contest, the uploading, the processing or judging of Applications or votes or the tabulating of votes, or in any Contest-related materials;
- 5) late, lost, undeliverable, damaged or stolen mail and/or communications arising from the Participant's participation in the Contest; and
- 6) any injury or damage to persons or property, which may be caused, directly or indirectly, in whole or in part, from the Participant's participation in the Contest and fruition of the prize, which is not due to negligence of Sponsor and/or Organizer.

N. GOVERNING LAW

These Terms and Conditions is governed by the laws of the Republic of Singapore, without regard to any choice of law provisions. All issues and questions concerning the construction, validity, interpretation and enforceability of these Terms and Conditions, or the rights and obligations of the Participant, the Organizer and the Sponsor, in connection with the Contest and/or any prize, shall be governed by, and construed in accordance with, the laws of the Republic of Singapore without giving effect to any choice of law or conflict of law rules (whether of the Republic of Singapore or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the Republic of Singapore.

O. DISPUTES

Participants agree that:

- 1) any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize awarded shall be resolved individually, without resort to any form of class action or representative proceedings, and the Participant hereby submits to the exclusive jurisdiction of the Courts of Singapore; and
- 2) to the extent permissible under applicable laws, under no circumstances will the Participant be permitted to obtain awards for, and the Participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other similar damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

P. GENERAL

The Organizer reserves the right to vary, modify, add or delete any of these Terms and Conditions.

In the event any Participant breaches any of these Terms and Conditions or the rules of the Contest, the Organizer shall have the right and discretion (after consultation with the Sponsor) to immediately disqualify the Participant without the need to notify the Participant. The Organizer's decision on this shall be final and no appeal from the Participant will be entertained.

Except for the Released Parties, no other party other than the Participant, Organizer and Sponsor shall have any rights under the Contracts (Rights of Third Parties) Act 2001 to enforce any term of these Terms and Conditions.

Attachment A RULES NATIONAL COMPETITION

CLOTHING AND BASIC CONDITIONS OF PARTICIPANTS
